The successful candidate will be proficient in Adobe Photoshop, InDesign, and Illustrator; present a portfolio showing an understanding of typography and page layout. The temporary Junior Graphic Designer must also have strong interpersonal skills and be detail-oriented and well-organized with the ability to handle multiple tasks and priorities. The position will report to the Interim Art Director/Graphic Designer.

RESPONSIBILITIES

Responsibilities include but are not limited to:

- Under the supervision of Interim Art Director/Graphic Designer, this position will work with
 colleagues across the museum on design projects by interpreting requests into accessible, onbrand materials for the BMA's audiences. Project examples include invitations, print and digital
 ads, and brochures.
- Create engaging materials aligned with the BMA's brand identity for Marketing, social media, Education, Advancement, and the overall institution.
- Support campaigns by adapting templates for different placements.
- Complete projects within the scheduled timelines
- Accompany and provide art direction to event photographers as needed.
- Help maintain inventory of MX materials.
